 - ____ *Initial* If the container is not returned within **20 days** of clearing customs **you will forfeit your entire tank deposit** which will be used by Select Breeders Southwest, Inc. to replace the container
 - ____ *Initial* **All Expenses associated with the tank return are the responsibility of the client.** Select Breeders Southwest, Inc. reserves the right to hold the tank deposit for up to 30 days after the tank is returned.
- 3) We prefer the container be returned directly to our facility by Federal Express.
 - **DO NOT use DHL to return the container.**
 - **If you must return the container by airline *please send it to JFK International Airport (New York, NY) to the attention of Mersant International.* You MUST fax a copy of the AWB to our office prior to shipment .**
